



SOFTWARE LICENSE AGREEMENT

PLEASE READ THIS AGREEMENT CAREFULLY BEFORE DOWNLOADING THE SOFTWARE ONTO YOUR COMPUTER OR OTHERWISE USING THE SOFTWARE. BY CLICKING ON THE "ACCEPT" BUTTON, OR DOWNLOADING OR USING THE SOFTWARE, YOU WILL BE BOUND BY THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THIS AGREEMENT, CLICK THE "DO NOT ACCEPT" BUTTON, OR IMMEDIATELY STOP DOWNLOADING AND USING THE SOFTWARE, IN WHICH CASE YOU WILL NOT BE AUTHORIZED TO DOWNLOAD OR USE THE SOFTWARE. IF YOU ARE AN INDIVIDUAL ACTING IN YOUR OWN CAPACITY, THE TERM LICENSEE IN THIS AGREEMENT REFERS TO YOU PERSONALLY. IF YOU ARE AN INDIVIDUAL ACTING ON BEHALF OF AN ENTITY, YOU REPRESENT THAT YOU HAVE THE AUTHORITY TO ENTER INTO THIS AGREEMENT ON BEHALF OF THAT ENTITY AND THE TERM LICENSEE IN THIS AGREEMENT REFERS TO THAT ENTITY.

This Agreement is between Formtek, Inc., a Pennsylvania corporation with offices at 1855 Gateway Boulevard, Suite 570, Concord, California 94520 (**Formtek**) and Licensee. This Agreement governs the accompanying software (**Software**) and the user guides and manuals for the Software generally distributed by Formtek (**Documentation**). This Agreement's effective date (**Effective Date**) is the date Licensee either clicks on the "accept" button, or initially loads or uses the Software, whichever occurs first.

1. Proprietary Rights, Delivery and Acceptance

- 1.1. Licensee acknowledges that the Software and Documentation are proprietary products of Formtek and its licensors, protected under U.S. copyright law and trade secret law. Licensee agrees that all right, title, and interest in and to the Software and Documentation, including all intellectual property rights, remains with Formtek and its licensors. This Agreement does not convey to Licensee any title or property interest in or to the Software or Documentation.
- 1.2. The Software and Documentation is being licensed to Licensee; they are not being sold to Licensee. This Agreement only grants a limited right of use which is revocable in accordance with this Agreement. This Agreement does not grant any license to any Formtek patents, copyrights, trademarks, trade secrets or other intellectual property rights, express or implied, except to the extent necessary to exercise the express license in this Agreement.
- 1.3. Licensee acknowledges that delivery of the Software and Documentation is by downloading and that no media or tangible products have been or will be delivered to Licensee. Licensee accepts the Software and Documentation upon downloading.

2. License Grant and Restrictions

- 2.1. Subject to Licensee's compliance with this Agreement, Formtek grants Licensee a worldwide, non-exclusive, non-transferable, non-assignable license to use the Software on the computer hardware platforms, operating system versions, and database software versions on which the Software was designed to operate (**Standard Platforms**) for its internal business purposes, and to use the Documentation with this permitted use of the Software. Licensee may only make copies of the Software and Documentation that are either necessary to use the Software or for backup purposes; provided that all copies include the proprietary, trademark and copyright notices included in the copy delivered to Licensee and all copies are subject to this Agreement. Formtek reserves all rights not expressly granted to Licensee.
- 2.2. Licensee shall not assign, sublicense, disclose, transfer, distribute, pledge, lease, rent, or share the use of the Software or Documentation with any third party (including any use for commercial time-sharing or service bureau purposes), except as expressly permitted by Formtek. Licensee shall not reverse engineer, create derivative works of, translate or otherwise modify the Software or Documentation, except to the extent expressly permitted in the Documentation. Licensee shall not copy the Software or Documentation, except as expressly permitted above. Licensee shall not remove, alter, or destroy any proprietary, trademark, or copyright notices included in the copy of the Software and Documentation delivered to Licensee.

3. Software Maintenance and Disclaimer of Warranties

- 3.1. The Software and Documentation is provided "as-is", Licensee is not entitled to any maintenance releases, bug fixes, workarounds, patches, minor variations, minor enhancements, minor improvements, or other updates, nor to any subsequent release of the Software which incorporates new or substantially changed variations, enhancements, improvements, features, functionality or other upgrades nor any other type of Formtek support.
- 3.2. FORMTEK DISCLAIMS ALL WARRANTIES, WHETHER EXPRESS OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE AND NON-INFRINGEMENT.

4. Term, Termination and Survival

- 4.1. This Agreement shall become effective on the Effective Date. This Agreement shall continue for an initial term of five years and then shall automatically renew for subsequent terms of two years each, unless at least sixty days prior to the end of the then current term, either party notifies the other in writing of its intention to have this Agreement expire at the end of the then current term.

- 4.2. Either party may terminate this Agreement if a material breach by the other party remains uncured for a period of thirty days after notice from the terminating party identifying the material breach and demanding cure.
- 4.3. Expiration or termination of this Agreement shall result in the simultaneous termination of all license rights granted hereunder. Upon expiration or termination, Licensee shall return or destroy all Software, Documentation and any copies thereof. Upon the expiration or termination of this Agreement, Sections 1.1, 2.2, 3, 4.3, 5, and 6 shall survive. The expiration or termination of this Agreement shall not limit either party from pursuing any other remedies available to it under law, including injunctive relief.

5. Limitations of Liability

- 5.1. In no event shall Formtek be liable for any indirect, incidental, special, exemplary, or consequential damages, or damages for loss of profits, revenue, data or use, incurred by Licensee or any third party, whether in an action in contract, tort, or strict liability, even if Formtek has been advised of the possibility of such damages.
- 5.2. In no event shall Formtek's liability for direct and general damages exceed \$50.
- 5.3. The Software includes components from third parties. In no event shall any of the vendors of these components be liable for any direct, indirect, incidental, special, exemplary, or consequential damages or damages for loss of profits, revenue, data or use, incurred by Licensee or any third party, whether in an action in contract, tort, strict liability, arising in any way out of the use of their components or the Software, even if such vendors have been advised of the possibility of such damages.
- 5.4. Licensee acknowledges that this Agreement is based in part on the forgoing limitations and further agrees that the forgoing limitations shall apply even if any limited remedy fails of its essential purpose.

6. Miscellaneous Provisions

- 6.1. The Software, including technical data, are subject to U.S. export control laws, including the U.S. Export Administration Act and its associated regulations, and may be subject to export or import regulation in other countries. Licensee will not re-export the Software to any country outside of the country of initial delivery by Formtek, without the prior written consent of Formtek. Licensee shall strictly comply with all applicable export control laws and shall obtain all necessary export control licenses to export or re-export the Software. Licensee will indemnify, defend and hold harmless Formtek and its successors, affiliates, directors, officers, employees and agents from and against any liabilities, damages, expenses, fines or penalties incurred as a result of the export or re-export by Licensee of the Software in violation of this Section.
- 6.2. If Licensee is the U.S. government, the Software is provided as a Commercial Item as set forth at FAR 2.101 "Definitions" and shall be acquired by the US Government as Commercial Computer Software and Commercial Computer Software Documentation in accordance with clause at FAR 12.212(a) which provides for license and use under the terms of this Agreement.
- 6.3. Licensee shall not assign or transfer (or attempt to assign or transfer) its rights or obligations under this Agreement, by contract, by operation of law or otherwise, without the prior written consent of Formtek, which consent will not be unreasonably withheld. Any attempt to transfer or assign this Agreement in violation of this Section shall be null and void. The waiver by either party of any default or breach of this Agreement shall not constitute a waiver of any other or subsequent default or breach. Amendments, modifications or supplements to this Agreement shall be permitted, provided all such changes shall be in writing signed by the authorized representatives of both parties, and all such changes shall reference this Agreement and identify the specific sections or provisions of this Agreement that is being amended, modified or supplemented.
- 6.4. Neither party is, nor shall either party represent itself to be, the agent, employee, franchise, joint venturer, officer or partner of the other party. Nothing in this Agreement shall be construed to place the parties in the relationship of partners or joint venturers, and neither party shall have the power to obligate or bind the other party in any manner whatsoever.
- 6.5. The substantive laws of the State of California shall govern this Agreement, excluding any choice of law rules. The provisions of the United Nations Convention of Contracts for the International Sale of Goods shall not be applicable. Any suit hereunder shall be brought in federal and state courts in of the State of California and the parties hereby submit to the personal jurisdiction of and agree that venue is proper in these courts. If a court of competent jurisdiction finds any provision or portion of a provision of this Agreement to be unenforceable, that provision of the Agreement will be enforced to the maximum extent permissible so as to affect the intent of the parties, and the remainder of this Agreement will continue in full force and effect. Except for actions for non-payment or breach of Formtek's or its licensor's proprietary rights in the Software, no action, regardless of form, arising out of this Agreement may be brought by either party more than one year after the cause of action has accrued.
- 6.6. This Agreement constitutes the entire understanding between the parties and supersedes any and all prior or contemporaneous oral or written communications regarding the subject matter of this transaction. Any terms in a purchase order submitted by Licensee to Formtek that are in additional to, or conflict with this Agreement, shall be null, void and of no force or effect, unless expressly agreed by Formtek in a written amendment to this Agreement.
